President's Letter

Welcome to our Spring issue! It has been a busy winter, and I would like to introduce our two new ITHA Board members. Thom Buchanan and Chris Murriel were elected last November after recently moving into our neighborhood. Join me in thanking them for stepping up to assist. You might also note that our officers are unchanged having been elected in January, and I want to thank Sandy Gandolfo and David Supan for continuing the fine job they have been doing.

This issue announces our ITHA Annual Garage Sale. It is earlier this year and scheduled for Saturday, April 22nd. So let the Spring cleaning begin, and sign up with the enclosed form so your address can be included. Also see the John Stacey's article announcing our first Landscape Day on May 21st. It should be a great way to meet other neighbors while sprucing up our residential park.

Since our annual meeting, the effort to achieve landmark status for the El Rey Theater has moved forward. In January the Historic Preservation Commission approved initiating the 6-month process to complete its designation. After which time, it will be eligible for state and federal tax credits to assist in its restoration and historically consistent development. This effort was spearheaded by the Art Deco Society of California with financial assistance from ITHA.

Your board, in concert with the West of Twin Peaks Central Council (WT-PCC), has been opposed to the de-forestation efforts of the Significant Natural Resource Areas Management Plan (NAP), and its removal of 18,000 eucalyptus trees in San Francisco and Sharp Park. Its EIR was approved by the Planning Commission in December and affirmed by the Board of Supervisors in February despite over six hours of predominantly opposing public feedback. However, motions to conditionally reverse this based upon developing findings by the Clerk of the Board were also passed, so it fortunately appears SF Rec. and Park does not yet have the go ahead that it is seeking.

As I have previously written here, the growth of short-term rentals in single family neighborhoods has both undermined valuable programs such as SAFE

as well as negatively impacted our quality of life in many cases. In February, I initiated a discussion at the WTPCC meeting which was also attended by Kevin Guy, Director of the Office of STRs. Director Guy confirmed that the City's registration requirements and fees plus taxes are being enforced and \$484-a-day penalties are being assessed for those not in compliance. For associations such as ours that have specific prohibitions in their CC&Rs, he affirmed that registration does not supersede these agreements and confer permission.

In this regard, your board has been executing on its responsibility to enforce our CC&Rs and notify residents when we are informed by the City of either violations or registration applications. I am pleased to report that upon receiving our letter they have either ceased or not started. However, we have begun to receive reports of an increase in this type of activity, some of which may simply be new residents. If you have not done so, please refer to the Second Article of the ITHA CC&Rs available on our website at www.ithasf.org and its prohibition of boarding and lodging use. In addition, I confirmed with Director Guy that such business activity requires an SF Business license and paid taxes upon the area used for rental. This removes the area from residential use which is also prohibited by the Seventh Article. Finally, if you are leasing or renting, please realize how this will impact your landlord who has agreed to be bound by the CC&Rs when the home was purchased and the potential legal jeopardy.

Finally, we are looking at bringing information and speakers to inform and impart your feedback to the monthly ITHA meetings. If there are any topics, city departments or speakers you wish to hear from, please email me directly at president@ithasf.org or reply to our agenda announcements.

He served as Medical Director of the Advanced Center for Wound Care at Seton. He published the first paper on carotid surgery without angiography and authored and co-authored numerous published articles on vascular and cardiovascular related topics.

The latest on Save the El Rey Theatre

Ocean Avenue Association, Art Deco Society and Save El Rey have successfully engaged the city's Historic Preservation Commission in landmarking El Rey. The process was initiated in January. The application will go before HPC once more, then the Board of Supervisors Land Use Committee and then the full board for two readings. "Long story short is that the property will be listed as a landmark by the end of the year," our historic preservation consultant Chris VerPlanck said. The new owners have hired an architect and are interested in working with the community as they develop their plans.

On April 5th, El Rey is scheduled to go back before the San Francisco Historic Preservation Commission for its second hearing where recommendation of its landmark designation to the Board of Supervisors will be considered. We are well on our way to making our moving picture palace a city landmark!
